

School Attendance Support Checklist

This checklist is a non-exhaustive guide which should be used as a tool for schools to assist in exploring and addressing the barriers to school attendance.

The list is not consecutive so does not have to be worked through in a particular order. Equally, not all sections will apply to all pupils, and there may be local variations in which services are available. However, the checklist provides areas for exploration and suggestions for support and further action and should therefore be reviewed thoroughly on a case-by-case basis. Hyperlinks have been included where appropriate to aid schools in accessing appropriate resources.

Interventions with an asterisk (*) are the strategies the authority feel should be the first port of call for attendance issues. It is also strongly recommended, if a school is considering legal interventions, to complete and evidence these attempts to provide support prior to submitting any referrals to the School Attendance Legal Team.

* Use of <u>Emotionally Based School Avoidance</u> (EBSA) resources within LCC guidance		
* Catch up work and support for filling gaps in learning provided		
* Support from school commissioned services (counselling, pastoral support, etc) as appropriate		
* Exploration of any familial issues which may impact attendance (domestic violence, parental health issues, Young Carer responsibilities, etc); please detail in outcome column including support offered/accessed		

* Reasonable adjustments made within school to address barriers to attendance which have been identified (ensure voice of child and parent has been captured)	
* Discussion with <u>School Attendance Support Team</u> (SAC/SASW) Advice can also be sought from local attendance clusters / via attendance Teams support	
* Consultation with School Nurse (if absences are related to medical concerns)	
* Concerns re peer group interaction addressed (eg bullying, isolation, social media related, youth crime, county lines, exploitation etc) and external support sought where relevant (please see below and list agencies in outcomes column)	
* Discussion with <u>Child and Family Wellbeing Service</u> (CFWS) Community Senior to explore local services which may be of benefit	
* Attendance contract initiated and monitored for 6 weeks/or a half term	
Reduced timetable offered (only where appropriate based on identified issues, time limited and with package of support to complement)	
Completion of the ATTEND framework (this is an additional EBSA resource available after taking the associated <u>training course</u>)	
SEND/Disadvantaged pupils	
* Consider if an EHC needs assessment is appropriate (for pupil with SEND)	
* Additional support provided within school to address poverty related barriers (eg uniforms, transport, sanitary products, etc)	
* Early review considered (for child with EHCP)	
Involved <u>Lancashire Specialist Teaching Service</u> and/or <u>Inclusion Engagement and Support Team (IEST)</u>	
Involved LA <u>Behaviour Consultant</u> or local Inclusion Hub	
Uniform adjustments for pupils with sensory needs	
Discussion with LA SEND case manager (for child with EHCP)
